in consideration of Fourteen Thousand and No/100 (\$14,000.00) Dollars and assumption of mortgage hereinafter set forth below, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

William H. Thomas, his heirs and assigns forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northerly side of Wilmington Road, near the City of Greenville, S. C., being known and designated as Lot No. 334 on plat of Botany Woods, Sector VII, as recorded in the RMC Office for Greenville County, S. C. in Plat Book YY, page 76 and 77 and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Wilmington Road, said pin being the joint front corner of Lots 334 and 335 and running thence with the common line of said Lots N 25-04 W 197.5 feet to an iron pin, joint rear corner of Lots 334 and 335; thence N 68-02 E 71.3 feet to an iron pin; thence N 68-16 E 130.5 feet to an iron pin; thence N 72-39 E 391.5 feet to an iron pin, joint rear corner of Lots 333 and 334; thence with the common line of said Lots S 0-50 E 263.3 feet to an iron pin on the northerly side of Wilmington Road; thence with the northerly side of Wilmington Road N 73-36 W 59.7 feet to an iron pin; thence continuing with said Road S 77-39 W 90 feet to an iron pin, the point of beginning.

This conveyance is subject to all restrictions, setback lines, roadways, easements and rights-of-way, if any, affecting the above described property.

As a part of the consideration herein the grantee does hereby assume and agree to pay the balance due of \$36,000.00, on that certain mortgage given by the grantors herein to First Federal Savings and Loan Association, in the face amount of \$36,000.00, dated March 9, 1967 and recorded on the same date in the RMC Office in Mortgage Book 1051, page 629.
