KNOW ALL MEN BY THESE PRESENTS, that I, Mary W. Bryson,

in consideration of Five (\$ 5.00) Dollars and assumption of mortgage set out below Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. H. Mauldin, his heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, near the Town of Travelers Rest, being known and designated as Lot No. 141 of Coleman Heights Subdivision as shown on plat thereof, recorded in the Office of the R. M. C. for Greenville County, South Carolina, in Plat Book RR at Page 115 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southern side of Alta Vista Circle, joint front corner of Lots Nos. 140 and 141, and running thence along the joint line of said lots, S.00-40 E. 231.5 feet to an iron pin; thence S. 89-26 E. 150.0 feet to an iron pin at the rear corner of Lot No. 142; thence along the line of that lot, N.00-40 W. 235.0 feet to an iron pin on the southern side of Alta Vista Circle; thence along the southern side of Alta Vista Circle, S. 89-20 W. 150.3 feet to the beginning corner; being the same conveyed to me by J. H. Mauldin by deed dated April 12, 1967.

The grantee herein expressly assumes and agrees to pay the balance due on a certain note and mortgage executed on April 12, 1967 in the original sum of \$ 15,000.00 by the grantor in favor of First Federal Savings and Loan Association of Greenville, recorded in the R. M. C. Office for Greenville County in Mortgage Book 1054, at Page 592, on which there is a balance due of \$ 15,103.53 as of this date.
