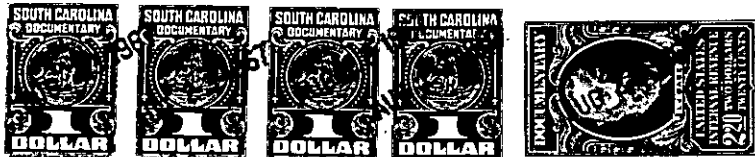
Know All Men by These Presents:

in consideration of the sum of Ten (\$10.00) - - - - - in the State aforesaid,  
and other valuable considerations, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Darrell Keith Genoble and his heirs and assigns forever:

All of those parcels or lots of land in Chick Springs Township of Greenville County, South Carolina, near the City of Greer and lying west therefrom, near the old Suber Mill, lying on the southeast side of a County road which leads into the Suber Road, and being shown as two(2) one-acre lots on a plat made for the Annie L. Copeland Estate on October 28, 1966 and thereafter revised and amended, having the following courses and distances:

BEGINNING on a stake in the center of said County road, joint corner with Tract A-1 on said plat (iron pin on southeast bank of road), and runs thence with the common line of said lots and Tract No. A-1, S. 18-25 E. 458 feet to an iron pin, corner with Tract A-2 on revised plat; thence with the line of that tract, N. 70-48 E. 151.3 feet to an iron pin on the common line of Tracts A-2 and A-3; thence along the line common with Tract A-3, N. 12-58 W. 552 feet to a stake in the center of County road (iron pin on southeast bank thereof), thence along the center of said road, S. 44-24 W. 203.9 feet to a stake; thence S. 55-59 W. 23.8 feet to the beginning, containing two acres, more or less.
