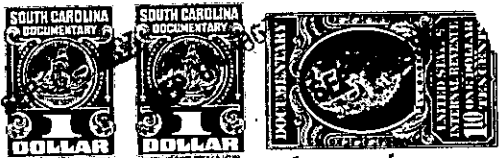
in consideration of Six Hundred Fifty and No/100-----(\$650.00)-----Dollars,
