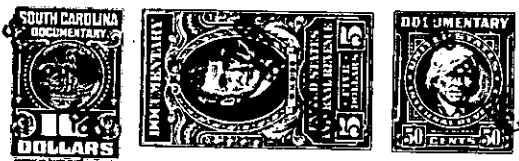
KNOW ALL MEN BY THESE PRESENTS, that Herbert E. Garrett
