the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Greenville County

I, hereby, deed unto Greenville County the following land to complete Spring Park Court Road and turn around together with strip being deeded by Mount Pilgrim Baptist Church as of this date.

BEGINNING at an iron pin in center of Spring Park Court Road thence S 48-45 W 25 feet to iron pin on corner Fred Workman property; thence S 30-30 W 272 feet to iron pin; thence S 1-00 W 96 feet to iron pin; thence S 32-30 W to iron pin approximately 50 feet in line with John Young property S 89-52 E 50 ft; thence N 21-10 E 49 1/2 ft. which constitutes a semi-circle for turn around purposes; thence N 8-35 E 115 ft; thence N 31-03 E 140 ft. to corner of Mount Pilgrim Baptist Church property; thence S 57-30 E 25 ft. to the center of Spring Park Court Road; thence with center of road 145 feet to beginning corner.
