Gambrell and his heirs and assigns forever:

All that certain piece, parcel or lot of land, and the improvements thereon, situate, lying and being in the State and County aforesaid, Chick Springs Township, about one mile southwest of Greer, S. C., lying on the northeast side of Edwin Drive, being shown and designated as all of Lot No. 14 and one-half of Lot No. 15, as shown on a plat of property for Florence H. Peace, by H. S. Brockman, Surveyor, December 15, 1949, and having the following courses and distances, to-wit:
