All that certain piece, parcel or lot of land, situate, lying and being in the County of Greenville, State of South Carolina, shown and designated as Lot G on a plat of property prepared for Dan E. Bruce by Webb Surveying & Mapping Co. dated December 30, 1965, which plat is recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book MMM at Page 135, and having according to said plat the following metes and bounds, to-wit:

Beginning at a point, joint corner of Lots 28, 29, G and H, and running thence N. 39-03 W. 90 feet to a point in line of Lot F; thence turning and running N. 50-57 E. 65 feet to a point, joint corner of Lots 25, 26, F and G; thence turning and running S. 39-03 E. 90 feet to a point in line of Lot 28; thence turning and running along the common boundary of Lots G and 28 S. 50-57 W. 65 feet to the point of beginning.
