WHEREAS, A. W. Hill County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against Alfred Gilliard, Jr. & L. have granted, bargained, sold and released, and by these presents do grant, sell, bargain and release unto the said grantee(s), M. T. Geddings

his heirs and assigns: All that lot of land in County of Greenville, State of South Carolina, known as Lot #162 as shown on plat of Tryon Development Company, known as Lake Lenier, with said Plat duly recorded in RMC Office for Greenville County.
