Bryant and their heirs and assigns forever, all that piece parcel or lot of land in Highland Township, Greenville County and State of South Carolina lying and being on the north side of that section of the Pack's Mountain Road that leads from Camp Creek Church to the Blind Tiger Bridge and having the following metes and bounds To Wit:

Beginning on an iron pin in the center of the rack's Mt. Road and running thence N. 67 - 54 W. 216 feet to a point in the center of said road; thence N. 41 - 11 W. 150 feet to a point in said road; thence N. 74 - 00 E. with Bobby Bomar's line, 247 feet to an iron pin; thence N. 70 - 00 E. 191 feet to a hickory tree; thence S. 20 - 00 W. 348.5 feet to an iron pin in the venter of said road, the beginning corner, and containing one and fifty-two ( 1.52 ) one hundredths acres, more or less.
