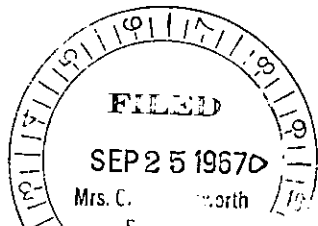

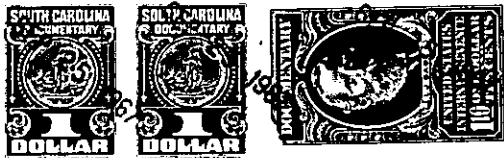
KNOW ALL MEN BY THESE PRESENTS, that I, Carl Howard, my heirs and assigns forever

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Essie Mae H. Jones her heirs and assigns forever:

All that lot or parcel of land lying, being and situate in the County and State aforesaid, Austin Township and in the Corporate limits of the Town of Simpsonville, and described as follows, according to a Plat prepared by L.C. Godsey, Surveyor, April 1956, of the Howard sub-division;

Lot no. 7 as shown on said Plat, with the following metes and bounds, to-wit: Beginning at an iron pin in the Eastern edge of Howard Circle, joint front corner with Lot no. 8, and running thence with the joint line of said Lot no. 8 S. 84-05 E. 307 feet to an iron pin, corner with said Lot no. 8, thence S. 46-32 W. 57.2 feet to an iron pin near branch; thence S26-18 E. 57 feet to an iron pin, back joint corner with Lot no. 6; thence N84-05 W. 301.5 feet to an iron pin in the Eastern edge of Howard Circle; thence with Howard Circle N. 5-55 E 90 feet to an iron pin at the point of beginning.
