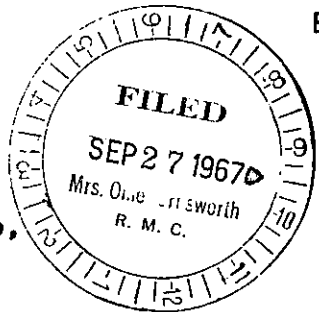

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

O. R. O'Shields and Virginia S. O'Shields, their heirs and assigns, forever:

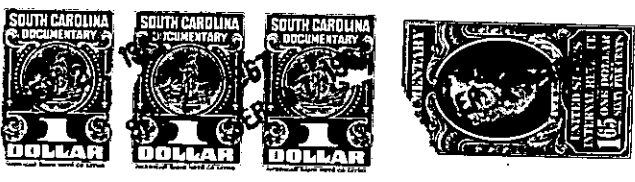
ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 17, as shown on a Plat of Laurel Hills by W. N. Willis, Engineers, dated March 1960 and recorded in the R.M.C. Office for Greenville County in Plat Book RR at Page 13 and having according to said Plat the following description, to-wit:

BEGINNING on Casa Loma Street at an iron pin at joint front corners of Lots 15 and 17 and running thence 80 feet with the line of said Street to an iron pin at joint front corners of lots 17 and 19; running thence 140.8 feet with the side line of lot 19 to an iron pin at joint rear corners of lots 17, 18, 19 and 20; running thence 80.4 feet with the rear line of lot 18 to an iron pin at joint rear corners of lots 15, 16, 17 and 18; running thence 132.8 feet with the side line of lot 15 to the iron pin at joint front corners of lots 15 and 17 on Casa Loma Street, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 30 feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes, only.

THIS conveyance is subject to all easements and rights of way of record.
