in consideration of the sum of One and No/100 (\$1.00)----- DOLLARS, and Love and Affection for my daughter to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Nell Means Nabers, her heirs and assigns, forever:

An Undivided Eighteen (18%) Per Cent interest in and to the following described real estate:

ALL that piece, parcel and tract of land with all buildings and improvements thereon in Greenville Township, Greenville County, State of South Carolina containing approximately 54 acres more or less and located on the Northeast side of White Horse Road and the Northwest side of Marion Road (formerly Means Road) and having the following description:

BEGINNING at an iron pin or point in White Horse Road at the intersection of Marion Road with White Horse Road and running thence along the center of Marion Road N 36 E 2082.30 feet to a point in the center of a private road or drive way corner with property now or formerly of J. E.
