to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto JOSEPH J. PAZDAN:

ALL that lot of land in Greenville County, South Carolina, known and designated as Lot Number Eighteen (18) of Section One of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the RMC Office for Greenville County in Plat Book YY at page 97, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin at the joint front corner of Lots 17 and 18 on the north-eastern side of Chanticleer Drive, and running thence with the northeastern side of Chanticleer Drive N. 25-24 W. 45 feet to an iron pin; thence still with the northeastern side of Chanticleer Drive N. 32-54 W. 74.5 feet to an iron pin at the joint front corner of Lots 18 and 19; thence with the line of Lot 19 N. 55-37 E. 187.7 feet to an iron pin on the line of F. H. Earle property; thence with the line of F. H. Earle property S. 28-21 E. 160 feet to an iron pin at the joint rear corner of Lots 17 and 18; thence with the line of Lot 17 S. 68-11 W. 184.5 feet to the beginning corner.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the RMC Office for Greenville County in Vol. 713 at page 221 and Vol. 716 at page 321.
