McCuen, her heirs and assigns, forever:

ALL that lot of land in Greenville County, South Carolina, in the City of Greenville, on the Western side of Ridgeland Avenue, being known and designated as the Southern one-half of Lot No. 31, and the Northern one-half of Lot No. 32 as shown on a Plat of Cleveland Terrace prepared by Dalton & Neves, Engineers, February 1926, recorded in Plat Book G at page 210, and described as follows:

BEGINNING at an iron pin on the Western side of Ridgeland Avenue, in the center of Lot No. 31, and running thence through the center of said lot, North 82-03 West 150.6 feet to an iron pin in the Eastern side of a ten-foot alley; thence with said alley, South 7-51 East 83 feet to a point in the center of the rear of Lot No. 32; thence through the center of said lot, South 83-12 East 154 feet to an iron pin in the Western side of Ridgeland Avenue, in the center of Lot No. 32; thence with said Avenue North 4-54 East 80 feet to the point of BEGINNING.
