**BEGINNING AT A NAIL AND CAP IN THE CENTER OF A COUNTY ROAD AND RUNNING THENCE ALONG THE CENTER OF SAID COUNTY ROAD, S. 82 W. 171 FEET TO A POINT; THENCE CONTINUING ALONG THE CENTER OF SAID ROAD, S. 86-20 W. 33 FEET TO A POINT; THENCE N. 4-30 W. 1,172 FEET TO A STAKE; THENCE S. 64-45 E. 428 FEET TO A STAKE; THENCE S. 20-15 W. 501 FEET TO A STONE; THENCE S. 15-55 E. TO A NAIL AND CAP IN THE CENTER OF SAID COUNTY ROAD, THE POINT OF BEGINNING, CONTAINING 4.41 ACRES, MORE OR LESS, AND BEING A PORTION OF THE LAND CONVEYED BY MARION COKER, AS SURVIVING EXECUTOR AND TRUSTEE UNDER THE LAST WILL AND TESTAMENT OF ROBERT O.
