All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, on the Eastern side of Hillcrest Circle, in the City of Greenville, being known as Lot Number 5, on Plat of the property of Central Realty Corporation, made by Dalton & Neves in August, 1946, recorded in the RMC Office for Greenville County, Plat Book Q, at page 3, and being more particularly described according to said plat as follows:
