ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Ninety-Nine (99) of Section Two (2) of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated August 30, 1965, and recorded in the R. M. C. Office for Greenville County in plat Book "JJJ" at page 71; and having, according to said plat, the following metes and bounds:

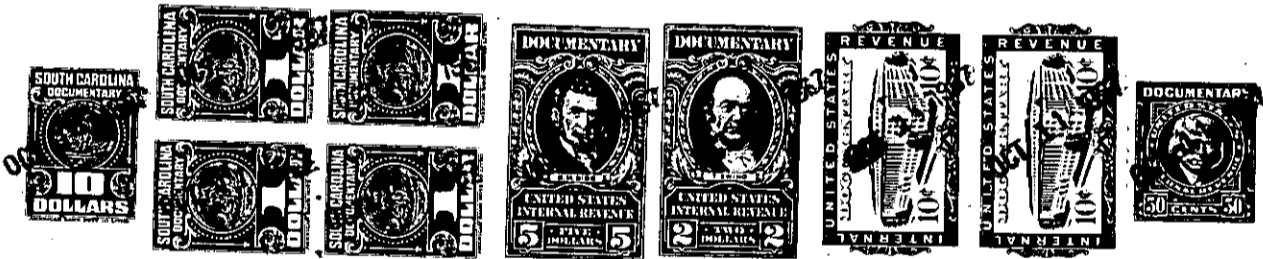
BEGINNING at an iron pin on the South side of East Seven Oaks Drive at the joint front corners of Lots 98 and 99 and running along said lot lines thence S 42-41 W 157.5 feet to an iron pin; thence turning and running along the rear lot line of Lot 99 S 51-53 E 120.45 feet to an iron pin; thence turning and running along the joint side lot lines of Lots 100 and 99 N 42-41 E 148 feet to an iron pin on East Seven Oaks Drive; thence turning and running along East Seven Oaks Drive N 47-19 W 120 feet to the point of beginning.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R. M. C. Office for Greenville County in Vol. 784 at page 329.

This is a portion of the property conveyed to Audubon Forest, Inc., by F. H. Earle by deed recorded in said R. M. C. Office in Vol. 700 at page 383. The name of Audubon Forest, Inc., was changed to Chanticleer, Inc., by instrument recorded in said R. M. C. Office in Vol. 712 at page 481.
