in consideration of THREE THOUSAND AND NO/100 (\$3,000.00) ----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HILTON SMITH, his heirs and assigns, forever:

ALL THAT CERTAIN piece, parcel or lot of land, with the improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on Hardale Court, being shown and designated as Lot No. 10 of Copeland Dale Subdivision, a plat of which by Jones and Sutterland, dated June, 1959, being recorded in Plat Book QQ at page 89 in the R. M. C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Hardale Court at the joint front corner with Lot No. 11 and running thence S. 70-41 W. 112.4 feet along the line of division of Lots No.s 10 and 11 to an iron pin; thence N. 21-13 W. 167 feet to an iron pin at the joint back corner of Lots Nos. 8 and 10; thence S. 78-57 E. 95 feet along the line of division of Lots Nos. 8 and 10 to an iron pin at joint corner of Lots No.s 8, 9 and 10; thence S. 64-14 E. 94.5 feet along the line of division of Lots Nos. 9 and 10 to an iron pin on Hardale Court; thence along a curve on Hardale Court, the chord of which is S. 10-19 E. 60 feet to an iron pin, the beginning corner.

BEING subject to the Restrictive Covenants applicable to Copeland Dale Subdivision as noted and recorded in Deed Volume 630 at page 159. Further this lot is subject to rights of way or easements of utilities now on record or to be put on record, and is subject to a two and one half (2½) foot drainage easement as shown on the plat.
