Eben Reavis Edwards, Jr., his heirs and assigns forever:

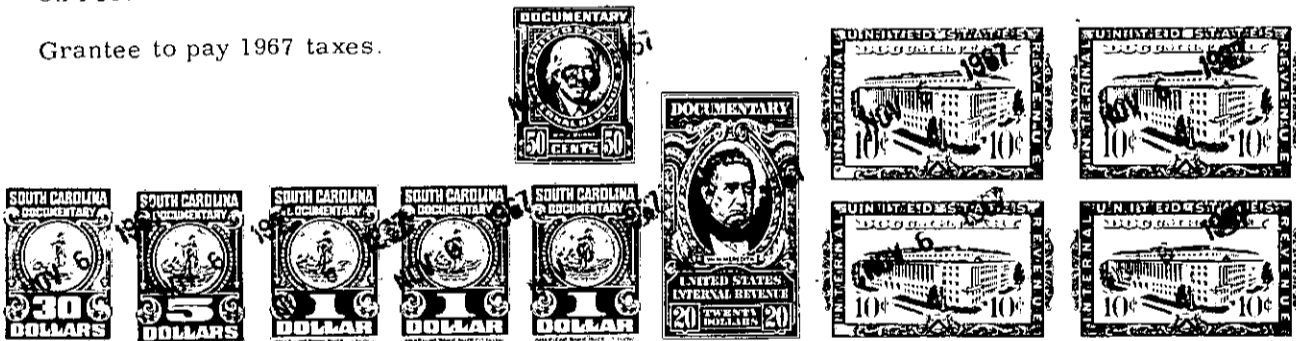

M. C. Office for Greenville County in Plat Book "RR", at Page 185 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Creighton Drive, joint front corner of Lots Nos. 3 and 4 and running thence with the common line of said lots N. 80-15 W. 150 feet to an iron pin; thence across the rear line of Lot No. 3 N. 9-45 E. 100 feet to an iron pin at the joint rear corner of Lots Nos. 2 and 3; thence with the common line of said lots S. 80-15 E. 150 feet to an iron pin on the western side of Creighton Drive; thence with said Drive S. 9-45 W. 100 feet to an iron pin, the point of beginning.
