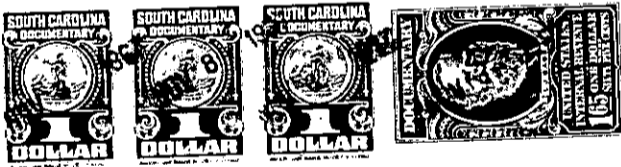

All that piece, parcel or lot of land situate, lying and being in the Town of Mauldin, County of Greenville, State of South Carolina, on the northern side of Sycamore Drive and being known and designated as Lot No. 70 on plat of Eastdale "JJJ", at Pages 50 and 51, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Sycamore Drive at the joint front corner of Lots Nos. 70 and 71 and running thence along the joint line of said lots N. 15-00 E. 200 feet to an iron pin; thence S. 75-00 E. 100 feet to an iron pin; thence along the joint line of Lots Nos. 69 and 70 S. 15-00 W. 200 feet to an iron pin on the northern side of Sycamore Drive; thence along said Drive N. 75-00 W. 100 feet to the point of beginning.
