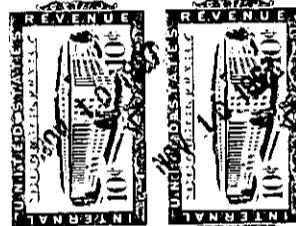

C. in Plat Book "YY" Page 93 and being more particularly described as follows:

BEGINNING at an iron pin on the South Side of Timrod Way, joint front corner of Lots 34 and 33 and running along the line of Lot 34 S. 56-08 E. 187.3 feet to an iron pin on rear line of Lot 41; thence along the rear lines of Lots 41 and 42 N. 33-55 E. 160 feet to an iron pin, joint rear corner of Lots 32 and 33; thence along the line of Lot 32 N. 56-05 W. 185 feet to an iron pin, joint front corner of Lots 32 and 33; thence along Timrod Way S. 33-55 W. 103.8 feet to an iron pin; thence continuing with Timrod Way S. 33-15 W. 56.2 feet to an iron pin, the beginning corner.

Subject, however, to those protective covenants and restrictions and the easements reserved therein, as recorded in the R. M. C. Office for Greenville County S. C. in Deed Book 723, Page 105; and also a building set back line no less than 50 feet from the street.
