release unto the said Marion Harris, his heirs and assigns, forever:

All that tract of land in Greenville Township, Greenville County, State of South Carolina, being Known and designated as Lot C in a subdivision of Lot 56 as shown on plat of property of Looper and Yown, said plat being recorded in the Office of the Register of Mesne Conveyance for Greenville County, South Carolina, in Plat Book F, Page 77, and having the following metes and bounds, to-wit: BEGINNING at a stake on the north side of Gordon Street 435 feet from the Old White Horse Road, corner of Lot 56-D, and running thence with line of Lot 56-DN. 10-15W. 200 feet; thence S. 79-45 W. 50 feet to an iron pin, corner of Lot 56-B; thence with line of Lot 56-B S. 10-15 E. 200 feet to an iron pin on Gordon Street; thence with Gordon Street N. 79-45 E. 50 feet to the BEGINNING corner.
