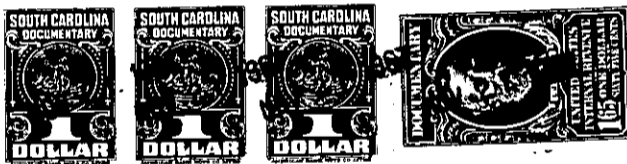

Traxler, prepared by Dalton & Neves, June, 1937, as recorded in Plat Book "II" at Page 97, R.M.C. Office for Greenville County, South Carolina, the following metes and bounds to wit:

BEGINNING at an iron pin on the easterly side of Rock Creek Drive Extension (formerly Ioka Street) at joint front corner of Lots 12 and 13 and running along the joint line of the said lots N. 64-40 E. 477.2 feet to an iron pin on the west bank of Reedy River; thence along the bank of the said River, the traverse line of which is S. 14-20 E. 51 feet to an iron pin on the said bank at joint rear corner of Lots 13 and 14; thence along the joint line of the said lots S. 64-40 W. 467.5 feet to an iron pin on the easterly side of Rock Creek Drive Extension (formerly Ioka Street); thence along said Drive N. 25-20 W. 50 feet to an iron pin, the point of beginning.
