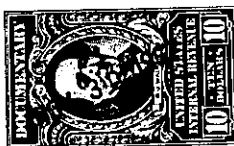
KNOW ALL MEN BY THESE PRESENTS, that I, Ward S. Stone, of Greenville County

unto Leonard Thompson, and Geniece M. Thompson, their heirs and assigns,

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 11 of a subdivision known as Pine Hill Village as shown on plat entitled "Property of Lanco, Inc." prepared by R. K. Campbell and Webb Surveying and Mapping Co., October 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 199, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Dunlap Drive, joint front corner of Lots 10 and 11 and running thence along the joint line of said lots, S. 66-25 E. 130 feet to an iron pin; thence S. 23-35 W. 70 feet to an iron pin at the rear corner of Lot 12; thence along the line of that lot, N. 66-25 W. 130 feet to an iron pin on the eastern side of Dunlap Drive; thence along the eastern side of Dunlap Drive, N. 23-35 E. 70 feet to the beginning corner.

This conveyance is made subject to any restrictions or easements that may appear of record, on the recorded plat(s), or on the premises.
