DEED of GIFT

KNOW ALL MEN BY THESE PRESENTS, that We,

J. Malvin Hunt
and
Louise J. Hunt,

in consideration of Love and affection, and One (\$1.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Jo Ann H. Crowley, her heirs and

Assigns, Forever:

ALL that piece, parcel or lot of land situate in Greenville County, State of South Carolina, on Jones Way, and designated as Lot No. 6 in the sub-division known as Hunts Villa, near the City of Greenville, South Carolina, as shown on a plat of said sub-division made by C. C. Jones & Associates, Engineers, and dated January 23, 1956, and having the following metes and bounds, according to said plat, to wit:

BEGINNING at an iron pin or point on the northern side of Jones Way, at joint corner of Lots Nos. 5 and 6, and running thence with the joint line of said lots N. 31-30 W. 150 feet to a point at rear joint corner of said lots; thence N. 58-30 E. 80 feet to a point at rear joint corner of Lots Nos. 6 and 7; thence with the joint line of said Lots Nos. 6 and 7, S. 31-30 W. 150 feet to a point on said Jones Way at front joint corner of said lots; thence along the northern side of said Jones Way, S. 58-30 W. 80 feet to the beginning corner.

And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s)' heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
