B. F. Reeves, his heirs or assigns, forever:

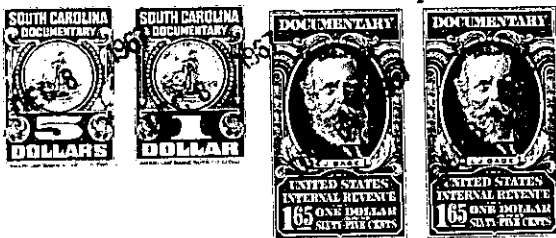
