the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto J. Odell Shaver, his heirs and assigns forever:

ALL of that lot of land in the County of Greenville, State of South Carolina, in Austin Township, near the Town of Mauldin and being known and designated as Lot No. 12 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R.M.C. Office for Greenville County In Plat Book BBB at page 15 and having the following metes and bounds, to-wit:

BEGINNING at a point on the southwestern side of Bartlett Street at the joint front corner of Lots 11 and 12 and running thence with the southwestern side of Bartlett Street S 47-51 E 85 feet to a point; thence following the curvature of the southwestern intersection of Bartlett Street with North Golden Strip Drive (The chord of which is S 02-51 E) 35.35 feet to a point; thence with the Northwestern side of North Golden Strip Drive, S 42-09 W 150 feet to a point at the joint corner of Lots 1 and 12; thence N 47-51 W 110 feet to a point at the joint rear corner of Lots 11 and 12; thence N 42-09 E 175 feet to the point of beginning and being same conveyed to us in Deed Book 782 at page 275.
