the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Gerald E. Honeycutt and Evalene B. Honeycutt, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 38 of a subdivision known as Avondale Forest, Section No. 1, as shown on a plat thereof prepared by Piedmont Engineers & Architects, dated July 3, 1964, recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 186, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Pryor Road, joint front corner of Lots 38 and 39 and running thence along the joint line of said lots, N. 48-48 E. 162.6 feet to an iron pin on the line of Lot 37; thence along the line of that lot, N. 40-45 W. 96.6 feet to an iron pin on the southeastern side of Drewry Road; thence along the southeastern side of said road, S. 64-43 W. 129.6 feet to an iron pin; thence following the curvature of Drewry Road as it intersects with Pryor Road, the chord being S. 15-24 E. 32.2 feet to an iron pin on the northeastern side of Pryor Road; thence along the northeastern side of Pryor Road, S. 33-55 E. 94.0 feet to an iron pin; thence continuing along the northeastern side of Pryor Road, S. 43-35 E. 20.0 feet to the beginning corner; being the same conveyed to me by Williams Land Company, Inc. by deed dated September 1, 1967 and recorded in the R.
