KNOW ALL MEN BY THESE PRESENTS, that OAK, INC.

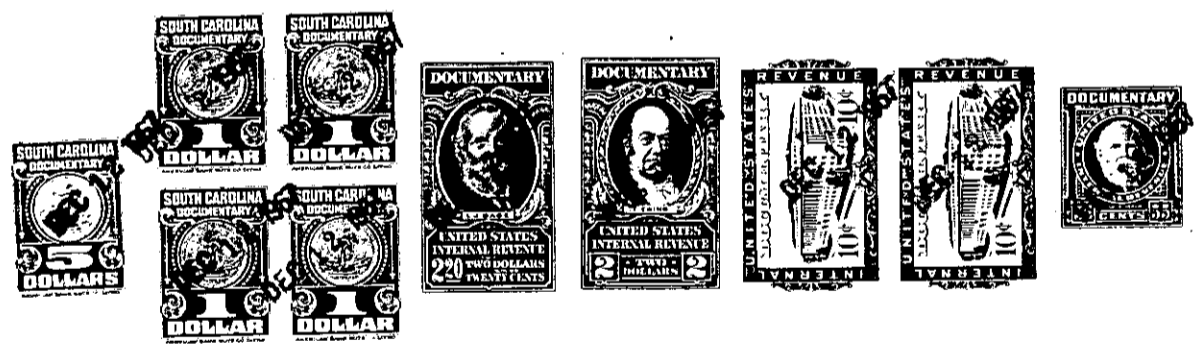

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto MARION E. HARRISON and MARGIE R. HARRISON, their heirs and assigns forever,

ALL that piece, parcel, or lot of land in the county of Greenville, state of South Carolina, situate, lying and being on Holly Road and being known and designated as Lot No. 51 on a plat of EDWARDS FOREST HEIGHTS as shown on said plat being recorded in the R. M. C. Office for Greenville County in Plat Book 000, at Page 87, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots 51 and 52 and running thence S. 1-29 E. 175 feet to an iron pin at the joint rear corner of said lots; thence along the rear line of Lot 51 N. 88-31 E. 110 feet to an iron pin at the joint rear corner of Lots 50 and 51; thence along the common line of said lots N. 1-29 W. 175 feet to an iron pin at the joint front corner of Lots 50 and 51 on Holly Road; thence along Holly Road N. 88-31 W. 110 feet to the point of beginning.

Office for Greenville County, South Carolina, in Deed Book 823, at Page 455, and this conveyance is made subject to restrictions, easements and rights-of-way appearing on record in the R. M. C. 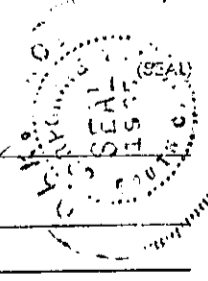
