2- Any dwelling erected on said lot shall be at least 30 feet from any street on which it fronts; shall contain at least 1200 Sq. ft of floor space on the first floor, exclusive of porches and garage; shall be equipped with a satisfactory septic tank or connected to sewer; purposes);

3- No outbuildings with the exception of a garage shall be erected within

75 feet of any street on which lot fronts;
4- No. pigs or goats are to be kept on said lot;
5- Any fence erected or used for the retention of animals other than domestic pets shall be at least 125 feet from any street on which lot fronts.
