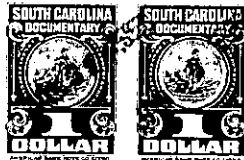
KNOW ALL MEN BY THESE PRESENTS, that I, VIRGINIA B. MANN OLLIE FARNSWORTH
