Received of the **SOUTHERN BELL TELEPHONE AND TELEGRAPH COMPANY ONE AND TWO** Dollars, in consideration of which **MC CALL - THREATT ENTERPRISES INC.** hereby grants said Company, its associated and allied companies, their respective licensees, successors and assigns, the right to construct, operate and maintain a line of communication consisting of such poles, wires, cables, conduits, guys, anchors and other necessary appurtenances as from time to time are required upon, across, and/or under that certain tract of land situated in **GREENVILLE** County, State of **SOUTH CAROLINA**, to-wit: **THAT TRACT OF LAND LYING NORTH OF PELHAM RD.
