Know All Men by These Presents:

That We, Clifton H. Simmons and Maude D. Simmons,

in the State aforesaid,

in consideration of the sum of Five (\$5.00) - - - - - DOLLARS, and love and affection for the grantees,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Charles Robert Simmons and Violet T. Simmons and their heirs and assigns forever:

All of that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, lying on the south side of the State Park Road, sometimes known as the Batson Road, about four miles east of the City of Greenville and near the old Reid School property, being shown on a plat of property made for Clifton H. and Maude D. Simmons by C. O. Riddle, Surveyor, dated January, 1968, to be hereafter recorded and having the following courses and distances:

BEGINNING at an iron pin on the south side of said highway at intersection with a community road, the northwestern corner of the lot conveyed herein, and runs thence along the margin of said highway, S. 49-13 E. 184.6 feet to an iron pin; thence S. 28-17 W. 221.8 feet to an iron pin; thence N. 61-37 W. 180.1 feet to an iron pin in the center of the community road; thence along the center of the community road, N. 28-15 E. 261.8 feet to the beginning, containing one acre, more or less, and being a portion of that property conveyed to the grantors by deed on record in the R.M.C. Office for Greenville County in Volume 253, at page 105.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors, and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
