KNOW ALL MEN BY THESE PRESENTS, that I, William Maxwell

in consideration of Four Thousand One Hundred Thirty Five (\$4,135.00) Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Thomas H. Gibbs, His Heirs And Assigns,

ALL those pieces and lots of land in Gantt Township, Greenville County, State of South Carolina, appearing on a Plat of Property of William Maxwell, dated July, 1965 by C. O. Riddle, Registered Land Surveyor, showing the property as Lots 2, 3, 4, and one unnumbered Lot to the rear of Lots 2, 3, 4, facing a future Street (now known as Deacon Street), the Lots being more particularly described as follows:

BEGINNING at an iron pin at the joint corner of Lots Number 1 and Number 2 on the Northern side of Jacobs Road and running along the line of Division of Lots Number 1 and Number 2, N. 26-51 W. 192 feet to an iron pin, joint corner of Lots Numbered 1, 2, and 19 (on other property of Grantor) and an unnumbered Lot, and running thence N. 41-58 E. 190.4 feet along line of division the unnumbered Lot and Lot Number 19 (on other property of the Grantor) to an iron pin on a Future Street (now Deacon Street) thence S. 66-05 E. 75 feet along said Street to an iron pin at corner of unnumbered Lot and Lot Number 4; thence S. 66-05 E. 125 feet to an iron pin; thence along a Chord S. 21-05 E. 35.3 feet to an iron pin on Maxwell Avenue; thence along Maxwell Avenue S. 23-55 W. 125 feet to an iron pin (pass line of division of Lots 3 and 4); thence along a chord S. 49-04 W. 37.7 feet to an iron pin being at the intersection of Maxwell Avenue and Jacobs Road, along line of Lot Number 3; thence S. 74-13 W. 78.3 feet to an iron pin at Line of Division of Lots Number 2 and 3; thence S. 64-53 W. 90 feet to the beginning corner on Jacobs Road.
