in consideration of the sum of Seventeen Hundred (\$1700.00) in the State aforesaid, DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Fred Alfred Hamby and his heirs and assigns forever:

All that parcel or lot of land in Oneal Township of Greenville County, South Carolina, located about one-half mile northwest of the City of Greer, lying on the east side of Cumberland Drive, being shown as Lot No. 9 on a plat of subdivision known as WOBURN COURT, by John A. Simmons, Registered Surveyor, dated December 11, 1963, recorded in the R.M.C. Office for Greenville County and having the following courses and distances:

BEGINNING on an iron pin on the eastern margin of said street, joint front corner of Lots Nos. 8 and 9 on said plat and run thence with the common line of said lots, S. 83-55 E. 172.6 feet to an iron pin; thence N. 4-36 E. 120 feet to an iron pin; thence N. 87-02 W. 172.6 feet to an iron pin on the margin of said street; thence S. 4-36 W. 111 feet to the beginning corner.

This is the identical property as conveyed to N. P. Satterfield by deed from W. Dennis Smith dated January 3, 1967, recorded in Deed Book 811, page 538, R.M.C. Office for Greenville County.

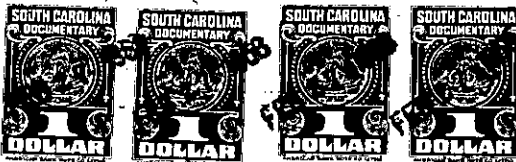
