release unto **J. E. MEADORS**, his heirs and assigns:

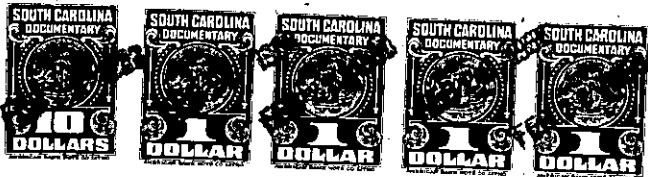
ALL that lot of land in Greenville County, South Carolina known and designated as

BEGINNING AT AN iron pin on the South side of Bartram Grove at the joint front
corners of Lots 110 and 111 and running thence S 38-33 W 171.9 feet to an iron pin; thence
turning and running along the rear lot line of Lot 111 S 51-55 E 120 feet to an iron pin;
thence turning and running along the joint lot lines of Lots 111 and 112 N 38-33 E 170.9 feet
to an iron pin on Bartram Grove; thence turning and running along Bartram Grove N 51-27W
120 feet to the point of beginning.
