KNOW ALL MEN BY THESE PRESENTS, that We, Manfred G. Martin and Joyce P. Martin

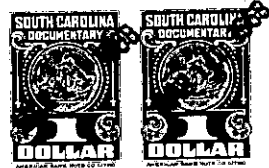
in consideration of Eight Hundred (\$800.00) Dollars,
