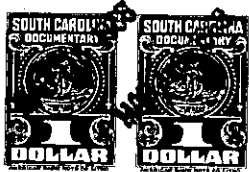

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

W. H. Pittman and Margie B. Pittman, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 75 as shown on a Plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 7, 1958 and recorded in the R.M.C. Office for Greenville County in Plat Book MM, at Page 55, and having according to said plat the following description, to-wit:

Lot 75 Pinewood Drive:

BEGINNING on Pinewood Drive at an iron pin at joint front corners of Lots 76 and 75 and running thence 90 feet with the line of said Drive to an iron pin at joint front corners of Lots 75 and 74; running thence 170 feet with the side line of lot 74 to an iron pin at joint rear corners of lots 74 and 75; running thence 90 feet, as shown on said Plat, with the rear line of lot 75 to an iron pin at joint rear corners of lots 75 and 76; running thence 170 feet with the side line of lot 76 to the iron pin at joint front corners of lots 75 and 76 on Pinewood Drive, the point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay taxes for year 1968.

together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in any wise incident or appertaining; to have and to hold all and singular the premises before mentioned unto the grantee(s), and the grantee's(s) heirs or successors and assigns, forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) heirs or successors, executors and administrators to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee's(s) heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
