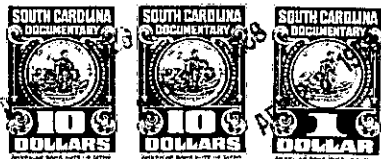
KNOW ALL MEN BY THESE PRESENTS, that I, Julian B. Barron
