All that piece, parcel or lot of land in the City and County of Greenville, State of South Carolina situate, lying and being on the western side of North Garden Circle and being known and designated as Lot No. 23 on plat of the Property of North Garden Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book "EE", at Page 63 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of North Garden Circle, joint front corner of Lots Nos. 22 and 23 and running thence with the common line of said lots S. 78-51 W. 164.2 feet to an iron pin; thence N. 10-10 W. 74.96 feet to an iron pin; thence with the common line of Lots Nos. 23 and 24 N. 78-51 E. 162.9 feet to an iron pin on the western side of North Garden Circle; thence with the northwestern side of said street S. 11-09 E. 75 feet to an iron pin, the point of beginning.
