ALL that lot of land lying on the Northeastern side of Pennwood Lane in Greenville County, South Carolina, near Paris Mountain, being shown as Lot No. 47 on a Plat of IMPERIAL HILLS, made by C. C. Jones, Civil Engineer, dated August, 1964, and recorded in the RMC Office for Greenville County, S. C., in Plat Book BBB, page 35, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northeastern side of Pennwood Lane at the joint front corners of Lots Nos. 47 and 48, and running thence N. 42-55 E., 155 feet to an iron pin; thence along the rear lines of Lots Nos. 37 and 38, N. 38-30 W., 80 feet to an iron pin at the joint rear corners of Lots Nos. 46 and 47; thence along the common line of said lots, S. 50-34 W., 168.8 feet to an iron pin on Pennwood Lane; thence along the Northern side of Pennwood Lane, S. 47-05 E., 100 feet to an iron pin, the beginning corner.

The above described property is conveyed subject to restrictive covenants applicable to Imperial Hills and to rights of way, easements and building setback lines shown on the aforementioned recorded plat and appearing of public record.
