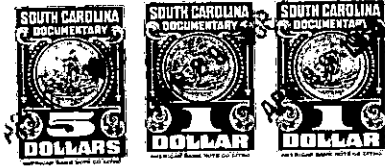
JOHN H. TAYLOR, JR., HIS HEIRS AND ASSIGNS, FOREVER:
