in consideration of the sum of One Thousand Two Hundred Fifty and No/100 (\$1,250.00) - - - - DOLLARS, and assumption of mortgage hereinbelow referred to,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) DENNIS G. ESTEP AND PHYLLIS S. ESTEP, THEIR HEIRS AND ASSIGNS FOREVER:

All that certain piece, parcel or lot of land, with all improvements thereon, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, on the western side of Brighton Lane about one mile southwestward from the Village of Taylors, being shown as Lot No. 65 of COLONIAL HILLS, recorded in the RMC Office for Greenville County, South Carolina in Plat Book "FFF", at Page 102, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Brighton Lane, joint front corner of Lots Nos. 64 and 65, and running thence along the joint line of said lots, N. 82-09 W. 169.9 feet to an iron pin; thence N. 9-22 E. 95.5 feet to an iron pin, joint rear corner of Lots Nos. 65 and 66; thence with the joint line of said lots, S. 76-50 E. 184.8 feet to an iron pin on the western side of Brighton Lane; thence with said lane, S. 19-43 W. 80 feet to the beginning corner.

This is the same property conveyed to the grantor herein by deed dated April 13, 1968, recorded in Deed Book 842, at Page 307 of the RMC Office for Greenville County, South Carolina.

The within conveyance is subject to utility easements, rights-of-way, and restrictions of record

As part of the consideration, the grantee assumes and agrees to pay the balance due on that certain mortgage from the grantees to Greer Federal Savings and Loan Association, said mortgage being in the original amount of \$14,850.00, dated March 4, 1966, and recorded in the Office of the RMC for Greenville County, South Carolina, in Mortgage Book 1024, at Page 449.

The grantor hereby transfers and sets over to the grantees the escrow account and insurance policy in connection with the above loan.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and the Grantee's(s') Heirs or Successors and Assigns forever.

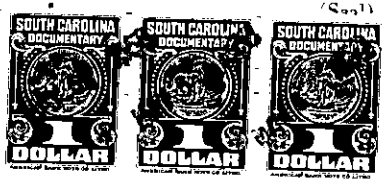
