All that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina near Simpsonville, S. C. known and designated as 1.13 acre tract as shown on plat of Property of J. R. Richardson, Sr., made by C. O. Riddle, L. S., dated May 1956, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of U. S. Highway 276 at the joint front corner of other property now or formerly of J. R. Richardson, Sr. and running thence N. 54-05 E. 427.2 feet to an iron pin on an unnamed road; thence with said unnamed road S. 31-15 E. 122 feet to an iron pin, joint front corner of a 1.25 acre tract; thence along the line of said 1.25 acre tract S. 54-05 W. 392.3 feet to an iron pin on U.
