All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the City of Greenville, being located on the west side of a sixteen (16) foot alley, said alley running between Walnut Street and Mauldin Street, and being known and designated as Lot 121 according to a plat of the Property of P. R. Long and Walter Goldsmith, made by Dalton & Neves, Engineers, in May, 1944 and said plat being recorded in the RMC Office for said County and State in Plat Book "O", at Page 21, and according to said plat being described as follows:
