ALL water lines, mains, valves and appurtenances installed and located in, under or along Leland Circle in the County of Greenville, State of South Carolina and specifically including approximately 1,640 feet - 2" Pipe; 4 - 2" Valves as shown on a Plat entitled "Walter J.
