ALL water lines, mains, valves and appurtenances installed and located in, under or along Blue Mountain Drive, East Sable Court and West Sable Court in Blue Mountain Park Subdivision, County of Greenville, State of South Carolina and specifically including approximately 962 feet - 3" Pipe; 2,850 feet - 2" pipe; 1 - 3" Valve; 5 - 2" Valves as shown on a drawing entitled "I.H.Philpot, J. E. Williams and Rex Carter to Berea Public Service District", attached hereto and made a part of this conveyance.
