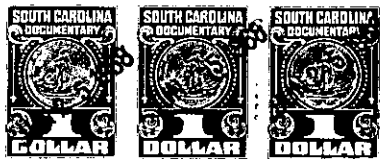
RIGHT OF WAY

FOR AND IN CONSIDERATION of the sum of \$ 1500.00 to the undersigned in hand paid by the Town of Simpsonville, S. C., the receipt whereof being hereby acknowledged, (I) (we) hereby grant unto said Town of Simpsonville, a right-of-way or easement along, over or under (my) (our) property for the purpose of installing and maintaining a sanitary sewer line, said right-of-way to extend 20 feet on each side of the center line during the construction and a permanent right-of-way of 12 feet, 6 inches on each side of the center line of said sewer line as installed and being 830 feet, more or less, in length. There are four manholes on this tract. Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said property is described as follows: Located in the Town of Simpsonville, being shown as Lot # 8.2, Block 1, Sheet 317 on the County Block Book. See Deed Volume 802, Page 67.

For information showing location of right of way over above described property, see plat filed in office of Town Clerk and Treasurer, Town Hall, for Simpsonville, South Carolina.

The real property above referred to shall have right to access to sewer line across said property and fees for tapping on said line and use thereof shall be the same as the current rate for other outside users of Town Sewer at time of use.
