the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Chas. A. Mundy, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being known and designated as Lot No. 37 of a subdivision of the property of Lanco, Inc. as shown on plat prepared by R. K. Campbell and Webb Surveying & Mapping Co., October, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book RR, at Page 199, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Malone Street, joint front corner of Lots Nos. 37 and 38, and running thence along the joint line of said lots, N. 71-02 E. 141 feet to an iron pin at the joint rear corner of Lots Nos. 40 and 41; thence along the rear line of Lot No. 41, N. 3-42 E. 85.14 feet to an iron pin at the joint rear corners of Lots Nos. 41, 43, 36 and 37; thence along the joint line of Lots Nos. 37 and 36, S. 71-33 W. 173.2 feet to an iron pin on the eastern side of Malone Street; thence along the eastern side of Malone Street, S. 18-30 E. 80 feet to the beginning corner.

This conveyance is subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 771, at Page 223, and is also subject to utilities and drainage easements which appear of record.
